- These figures reflect the renewables that we have contracted to provide. Actual figures may vary according to resource availability. We will annually report to you before October 1 of next year in the form of a Historic Product Content Label the actual resource mix of the electricity you purchased.
- 2. New Renewables come from generation facilities that first began commercial operation within the past 15 years.

For comparison, the current average mix of resources supplying California includes: Eligible Renewables (31%), Coal (3%), Nuclear (9%), Natural Gas (35%), Large Hydroelectric (11%), and Unspecified Sources of Power (11%). This resource mix is an annual estimate prepared by the California Energy Commission based on the electricity sold to California consumers during 2018.

The average home in San Francisco uses 283 kWh per month.


