



# Monthly Bill Discounts to Help You Save

CleanPowerSF is committed to providing our customers with clean energy that is affordable and accessible to all. As a CleanPowerSF customer, you are eligible for discount programs administered by PG&E. You do not need proof of income to enroll. **Learn if you qualify for a monthly discount on your energy bill and apply today.**

## Which program is right for me?



### **CARE** (California Alternate Rates for Energy Program)

Eligibility based on public assistance program participation (like Medicaid or food stamps) or based on the number of individuals in your household and your total gross household income.

**Reduces electricity bills by 35% and gas bills by 20%.**



### **FERA** (Family Electric Rate Assistance Program)

Eligibility based on the number of individuals in your household and your total gross household income. FERA is only available to households of 3+ people.

**Reduces electricity bills by 18%.**

## How do I enroll?

Review the requirements on the reverse side of this page. If you believe your household qualifies, you should submit an application. Renewals and new enrollment applications are handled by PG&E.

# Learn if your household qualifies...

Review the guidelines below to see if you qualify for CARE or FERA. Note: you can qualify for CARE by meeting income requirements OR participating in a listed public assistance program.

## Total Gross Income (CARE and FERA):

Income requirements listed for CARE and FERA reflect your household's current income as of today. If you had a change in circumstances such as job loss, you may now qualify. You may still qualify even if you are receiving unemployment benefits.

## Public Assistance Program Participation (CARE only):

You can also qualify for CARE if you or someone in your household participates in any of the following programs.

- Low Income Home Energy Assistance Program (LIHEAP)
- Women, Infants, and Children (WIC)
- CalFresh/SNAP (Food Stamps)
- CalWORKs (TANF) or Tribal TANF
- Head Start Income Eligible (Tribal Only)
- Supplemental Security Income (SSI)
- Medi-Cal for Families (Healthy Families A & B)
- National School Lunch Program (NSLP)
- Bureau of Indian Affairs General Assistance
- Medicaid/Medi-Cal (under age 65)
- Medicaid/Medi-Cal (age 65 and over)
